

**RED ANGUS SHOW AND SALE ENTRY INFORMATION  
WATERTOWN WINTER FARM SHOW, WATERTOWN, SD**

- TIME & PLACE:** THE SHOW WILL START AT 10:00 AM. THE SALE STARTS AT 2:00 PM WEDNESDAY OF FARM SHOW WEEK. THE CATTLE WILL BE HOUSED AT THE WATERTOWN WINTER FARM SHOW EXTENSION BUILDING. CATTLE CAN ARRIVE ON MONDAY OF FARM SHOW WEEK. ONE BLOCKING CHUTE PER CONSIGNOR.
- ENTRY FEE:** **BULLS \$100 PER HEAD AND FEMALES \$50 PER HEAD, PAYABLE TO SOUTH DAKOTA RED ANGUS ASSOCIATION.** CONSIGNORS MUST BE PAID MEMBERS OF THE STATE ASSOCIATION (DUES ARE \$100 PER YEAR), AND PAID MEMBERS OF THE NATIONAL ASSOCIATION PRIOR TO THE DATE OF THE SHOW. IF A JUNIOR MEMBER IS CONSIGNING CATTLE THE SDRAA DUES ARE \$50 PER YEAR. IF CATTLE ARE EXHIBITED AND SOLD UNDER JOINT OWNERSHIPS ALL PARTIES MUST BE PAID SDRAA MEMBERS
- ENTRY DEADLINE:** ENTRIES MUST BE RETURNED TO JARED NAMKEN, SALE MANAGER, BY NOVEMBER 20<sup>TH</sup> WITH ENTRY FEE AND SDRAA DUES IF YOU ARE NOT A CURRENT MEMBER. USE ENTRY BLANKS PROVIDED ON WEBSITE. MAKE COPIES IF NEEDED. PLEASE PRINT SO WE CAN READ THE ENTRIES.
- BULLS AND FEMALES:** ALL ANIMALS MUST BE **REGISTERED 1A WITH REGISTRATION PAPERS PRESENTED AT CHECK IN.** BULLS MUST BE BORN BETWEEN JANUARY 1<sup>ST</sup> TWO YEARS PRIOR TO SHOW YEAR (25 MONTHS OLD) AND APRIL 15<sup>TH</sup> ONE YEAR PRIOR TO SHOW YEAR (10 MONTHS OLD). FEMALES MUST BE BORN AFTER JANUARY 1<sup>ST</sup> TWO YEARS PRIOR TO SHOW YEAR (YOUNGER THAN 25 MONTHS). FEMALES OVER 20 MONTHS OF AGE MUST BE SAFE WITH CALF AND BULLS MUST BE SEMEN CHECKED. ALL BULLS MUST MEET THE STATE GUIDELINES FOR TRICHOMONIASIS. CHECK WITH YOUR LOCAL VETERINARIAN CONCERNING THESE GUIDELINES. ALL CATTLE MUST BE OF GOOD QUALITY, GENTLE, HALTER BROKE AND ABLE TO BE LED. ALL CATTLE MUST BE REGISTERED IN CONSIGNORS NAME FOR AT LEAST SIX MONTHS PRIOR TO THE SHOW. BULLS ARE REQUIRED TO BE SHOWN WITH A NOSE LEAD.
- HEALTH:** INDIVIDUAL HEALTH PAPERS TO PROVE THEIR ELIGIBILITY FOR INTERSTATE TRAVEL AND A BREEDERS GAURANTEE MUST ACCOMPANY CATTLE. PLEASE REMEMBER THE TRICH RULES IN SOUTH DAKOTA. **ALL HEALTH PAPERS ARE REQUIRED TO BE TURNED IN TO SALE MANAGER AT CHECK IN.**
- SALES COMMISSION:** A COMMISSION OF 10% WILL BE CHARGED. ENTRY FEE WILL BE DEDUCTED FROM THE TOTAL COMMISSION. ENTRY FEE WILL BE FORFEITED ON CATTLE THAT ARE SCREENED OR WITHDRAWN. SALE WILL BE CONDUCTED UNDER THE RULES OF THE RAAA.
- REMINDER:** THE SALE COMMITTEE RESERVES THE RIGHT TO SCREEN OUT ANY CATTLE THAT WILL NOT BE A GOOD REPRESENTATION OF THE RED ANGUS BREED. SALE COMMITTEE MAY SCREEN CATTLE OUT OF THE SALE ANY TIME PRIOR TO THE START OF THE SALE. ENTRY FEE WILL BE RETURNED ON CATTLE SCREENED OUT PRIOR TO CATALOGS BEING PRINTED. ENTRY FEE WILL NOT BE RETURNED ON CATTLE SCREENED OUT AFTER CATALOGS ARE PRINTED. **NO CATTLE WILL BE CATALOGED WITHOUT ENTRY FEES PAID!!!!**
